Background

Aim

GOVERNANCE

Higher education governance and its autonomy is strongly enhanced by the effective and convincing accountability, transparency and financial sustainability.



ACCOUNTABILITY

In spite of the challenges, higher education institutions should invest more in dealing with issues of social, academic and financial accountability to students and to the community at large.



AUTONOMY

The autonomy and university transparency take different forms in each country, however the intense debates between higher education institutions and the government manifest the need to foster the mechanisms that lead to strong university governance and increased accountability and transparency.

BEST EUROPEAN PRACTICE

To foster the transition of higher education system towards decentralized, autonomous governance and the capacities of national authorities in Western Balkans, the consortium took the initiative to address such important topic with an increasing demand for comparability and benchmarking university structure across borders using the case of Kosovo, Albania and Montenegro following the standards of the University Autonomy practices in Europe.

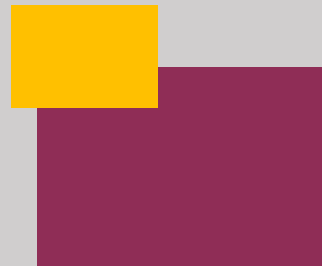

- Empowered university autonomy in main dimensions: organizational, staffing, financial, and academic levels
- Harmonized practices between HEIs and relevant ministries using the example of EU partners and upgraded University regulations
- Established Expert's Network on University Autonomy



INNOVATIVE CHARACTER

1. Development of university autonomy scorecard for Kosovo, Albania, Montenegro, internationalization approach that will enhance ongoing and complementary collaboration between universities, policymakers, and EU partners. This essential link is still considered weak in target countries with a traditional higher education system.
2. Enhanced links between university and ministry will improve university autonomy and will provide better educational outcomes that have a direct impact on labour market productivity and society as a whole.
3. Adoption of holistic university reforms accompanied with appropriate support for skills and organizational structure development in Kosovo, Albania and Montenegro.
4. Formation of a group of experts trained by STAND for the dissemination of knowledge on university autonomy in general and specifically for the case of Kosovo, Albania and Montenegro.

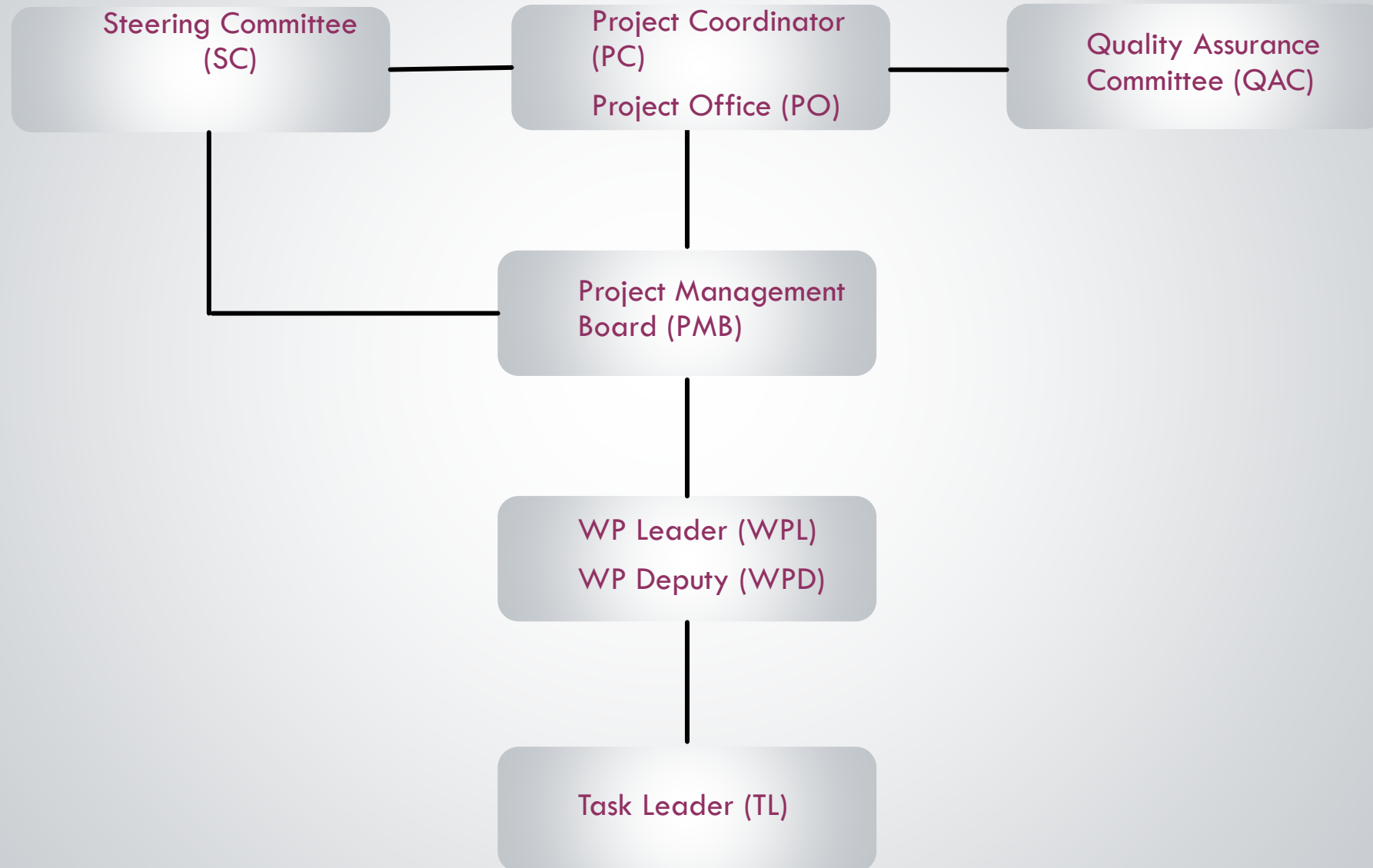

IMPACT

- STAND will update the national strategy in higher education and contribute to the reforms the HEIs in the region that will strengthen the university autonomy, as well as accountability and transparency.
- STAND will provide a recommendation on adapting/ upgrading of standards that ensure adequate university governance, an increase of study programmes in line with labour market requirements, the promotion of scientific research, and the facilitating of artistic work and innovation in higher education institutions.
- STAND will streamline & simplify rules and regulations, to bridge the gap between theoretical and real autonomy; set the appropriate balance of autonomy and accountability.
