- **General overview of the institution**

- **The University of Gjakova “Fehmi Agani” (UGJFA) is a descendant of the High School that prepared the teachers during the second half of the sixties (1968) and of the University of Prishtina. The government of Kosovo established the Public University of Gjakova which began operating since 1 October 2013 with three Faculties:**
 - **Faculty of Education;**
 - **Faculty of Medicine;**
 - **Faculty of Philology**
 - Faculty of Applied Sciences;
 - Faculty of Social Sciences.

- **UGJFA with its existing accredited academic units together with planned new programs have the consent of qualitative staff in relevant fields. Studying programs are drafted based on Bologna system and foresees the transfer of credits, and are closely related to the labour market requests in place, region and even wider.**

- **University autonomy**

Our universities has four main dimensions of relative autonomy:

- **Academic;**
 - **Organizational;**
 - **Financial and**
 - **Staff autonomy.**

- We do apply Bologna study system, and do apply for accreditation.
 - When it comes to finances we do report and manage the state grant that is foreseen by government for our institution and for moment, it goes through MEST.

Academic and Financial Accountability

The University of Gjakova 'Fehmi Agani' highly values the protection of the academic integrity of professors and insists on maintaining their professional ethics based on institutional regulations. This commitment of the university has been confirmed by the monitoring of central institutions and civil society organizations which deal with the assessment of academic integrity in higher education institutions in the Republic of Kosovo. The University's commitment to academic integrity is ongoing.

The Strategic Plan of the University envisages one of the strategic objectives "Quality Assurance and Academic Integrity" while concrete activities envisage:

- a) drafting the Manual for Academic Ethics which will contain guidelines to avoid fraudulent journals and
- b) b) training on academic ethics with academic staff and with students.

Academic and Financial Accountability

In terms of regulations, the University of Gjakova has:

- **Code of Ethics** which has been approved by the Governing Council and which is in line with the University Statute and the European principles of protection of academic integrity in teaching and scientific research. Through this Code the university aims to protect academic integrity, the values of academic freedom, institutional autonomy and ethical integrity.
- **Code of Ethics for Administrative Personnel** which aims to establish ethical rules of conduct for administrative staff, in accordance with the highest professional standards of work, impartiality and independence in the exercise of public office and in the performance of duties and responsibilities. The Code of Ethics for Administrative Personnel aims to avoid all forms of discrimination and abuse, govern conflict of interest, improve the organizational climate and work environment, prevent unethical and illegal behaviour.

Academic and Financial Accountability

- The Ethics Council;
- Disciplinary Commission;
- Law on Public Financial Management and Accountability, and follows the Budget Law for the Fiscal Year according to the budget limits approved by the Assembly of Kosovo;
- Kosovo Financial Management System (KFMIS) is applied, which is an integrated system for budget expenditure oversight procedures by Budget Organizations, with a high control by the Kosovo Treasury and the CBK;

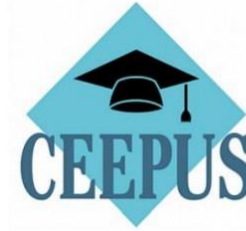
